A key component of every home care package, which ensures that consumers can access relevant, clinically safe, and effective personal care, which is responsive to their needs.	Covers the ongoing organisational activities associated with ensuring the smooth delivery and management of a home care package, which includes preparing monthly statements; managing package funds; and compliance and quality assurance activities.	The income tested care fee is an extra contribution that some people are required to pay, as determined by Services Australia in an income assessment. This fee is different for everyone and is based on your individual income, including your pension. Full pensioners and people with an income up to \$28,974.40 do not pay an income tested care fee. This is not payable from your home care package.
