To Whom It May Concern,

Thank you for the provided documentation and your request to confirm your Aboriginality. SETAC are happy to review any documentation provided, however, we do not have the capacity to complete any further research on any documentation we receive.

Your information will be presented to the Board of Directors at their meetings which are held 4-6 weekly. If your documentation is sufficient and the Board of Directors are aware of your family, your history, your active role in our local Aboriginal community and SETAC, the confirmation will be accepted and signed.

If the documentation is not sufficient and you are a local resident it will be returned to you to provide further evidence of your claims.

In the event that you are not and have not been an active participant within SETAC or your local community as an Aboriginal person SETAC will allow a 12 months period for this to be rectified. Please return your confirmation documents after 12 months to be reviewed.

The confirmation criteria are as follows:

- (1) You must have Aboriginal or Torres Strait Islander Ancestry
- (2) You must self-identify as an Aboriginal or Torres Strait Islander
- (3) You must be recognised as an Aboriginal or Torres Strait Islander by the Aboriginal or Torres Strait Islander community in which you live or have lived.

SETAC will not approve confirmations for people not known as Aboriginal or not from our Community.

Aboriginal people outside of the South East Tasmanian Aboriginal community should seek assistance to have their Aboriginality confirmed with their local Aboriginal Organisations.
